# BCCJ EXECUTIVE COMMITTEE ELECTION BOOKLET







Since 1948, the British Chamber of Commerce in Japan (BCCJ) has been at the heart of UK-Japan business. Thanks to the efforts of the companies and individuals in the network, the chamber has developed into an exceptionally active, not-for-profit private membership organisation comprising of over 200 firms.

Over the next 12 months, we will charter into exciting territory for UK-Japan relations. Preparations are in full swing for the Osaka Expo 2025, in which the UK will focus on global collaboration with the world to save lives - human, wildlife and planet. Bigger picture, 2023 saw trade between the UK and Japan grow 2.9% (or £777 million) to £27.8 billion (exports plus imports) and we expect this number to continue its upward trend in the year ahead. The BCCJ is designing an inclusive programme with its membership positioned at the forefront, to take advantage of new opportunities and continue tell the innovative and successful stories of our members.

As a 21st century business development hub, the BCCJ has been seeking new and creative ways to facilitate access to connections, clients, customers and opportunities for its members. Through the development of creative platforms for knowledge sharing and networking, the chamber continues to deliver traditional member services, including events, promotion, business concierge and consultancy. All of the above will be achieved with the guidance and strategic direction from the 2024-2025 BCCJ Executive Committee (Excom).

#### WHAT IS EXCOM?

The BCCJ's Excom consists of a minimum of twelve (12) and a maximum of fifteen (15) members. The role of Excom is primarily a strategic one; the elected candidates will decide the purpose and the overall goals of the BCCJ and sets a framework for their implementation and achievement.

The key responsibilities of Excom are to:

- Set suitable organisational aims and objectives
- Set a budget which allows the BCCJ to fulfil its purpose
- Agree policies, targets and priorities
- Monitor and review the performance of the BCCJ and the executive team

The Excom seeks an appropriate balance of members of the business community with specific skills and experiences that will benefit the BCCJ and its membership at large. Excom members serve for a one-year term (April 2024 - March 2025). The Excom officially meets 11 times during the year, excluding the month of August. Excom members are expected to attend the monthly Excom meetings and the BCCJ Annual General Meeting held in April, as well as other activities throughout the year to hear from members and feed back any suggestions to the BCCJ executive team.


